

# MSP Perspectives

#### **Naval HADR and Super Typhoon Haiyan**

THE international response to Typhoon Haiyan, which cut a swath of destruction though the central Philippines on 8 November, has underscored the naval dimension to Humanitarian Assistance and Disaster Relief (HADR) operations in Asia. The U.S., U.K. and Japan all deployed military assets commensurate with their large civilian aid efforts. Several ASEAN members also deployed defence assets, bilaterally, to support the relief operation. However, questions remain about the lack of a coordinated response within Southeast Asia, given the prominence that HADR cooperation has had within ASEAN itself, the ASEAN Regional Forum (ARF) and the ADMM-Plus.

Naval assets are only one part of the HADR toolkit, which remains civilian-led. But navies are often first on the scene. Suitably trained and equipped, they bring ready-made capabilities and skilled personnel for damage assessment, delivering emergency supplies directly to the point of need. Ship-based communications can help to direct the wider relief effort when land-based civilian infrastructure is insufficient.

Navies' ability to operate autonomously offshore confers unique advantages. It can help overcome land-based logistical bottlenecks. Politically, it can also mitigate the sensitivities of local populations towards a foreign military presence. Beyond the "first response" phase, a floating presence just out of sight gives relief workers and vulnerable evacuees temporary respite in a safe "rear area" that carries its own force protection.

As was the case following the Indian Ocean tsunami in December 2004, a U.S. aircraft carrier and its accompanying escorts were able to respond quickly. The USS George Washington commenced relief operations in the Philippines within the first week, ferrying emergency supplies and fresh water to affected areas. The 21 helicopters within its group, augmented by U.S. Marine Ospreys deployed from Okinawa, provided an indispensable front-end airlift capability for the relief effort. Although the carrier group has now departed, the U.S. Navy's hospital ship USS Mercy is expected to join the relief effort in December after crossing the Pacific.

The U.K. Royal Navy, after a prolonged absence from the region, was fortuitously well placed to respond. HMS Daring, a Type-45 destroyer, was diverted from the South China Sea to deliver assistance near Cebu. HMS Illustrious, with a complement of seven helicopters, was also committed to the relief effort. While Illustrious brings far more capability, the fact that Daring and her crew were able to respond immediately demonstrates the flexibility of other warships in the HADR role.

The naval element is also prominent in Japan's largest peacetime overseas deployment of the Self Defense Forces, involving 1,100 personnel, 16 military aircraft and three ships, including the flat-topped JDS Ise, which can carry several helicopters and a large volume of stores. China's navy also belatedly dispatched a hospital ship to the Philippines.

The more surprising omission was ASEAN, given its recent focus on HADR. For example, an ARF exercise in Thailand this May was designed to "rapidly provide coordinated and effective disaster relief". In June, Brunei and Singapore co-hosted a combined military medicine/HADR exercise "to enhance interoperability and understanding through cooperation and contribution of military assets and personnel from ADMM-Plus nations." ASEAN's Secretary General is also dual-hatted position as ASEAN's Humanitarian Assistance Coordinator.

Singapore, Brunei, Thailand and Indonesia provided mostly air transport in terms of military assistance. ASEAN's Coordinating Centre for Humanitarian Assistance on disaster management did manage to pre-position personnel in the Philippines. However, comments attributed to the Thai and Indonesian foreign ministers in Bangkok on 14 November suggested mounting frustration that ASEAN's response was materialising more slowly than those from extra-regional countries. Thai Foreign Minister Surapong Tovichakchaikul proposed that "a quick response team is needed for ASEAN, the 10 countries have human resources and enough equipment, so it is time to share and cooperate."

At the national level, while ASEAN's armed forces capabilities are limited, even niche contributions can be useful, provided personnel are trained and that a coordinated response plan is worked out in advance. Having made HADR the centrepiece of recent defence cooperation exercises, ASEAN's piecemeal response to the real-life disaster in the Philippines has exposed a need to operationalise HADR rapid response among its members, not only leveraging upon the capabilities of their external partners.

Beijing is currently embroiled in a diplomatic row with Japan after Chinese forces set up an air defence zone over the East China Sea over the weekend which includes disputed islands also claimed by Tokyo.

#### Japanese ships disrupt Chinese military exercises

Sino-Japanese ties have been strained for months by a dispute over tiny islands in the East China Sea believed to be surrounded by energy-rich waters.

#### North Korea reveals warship sinking

North Korea has revealed that one of its warships sank last month, killing a number of sailors, in a rare admission of military failure. State media reported a visit by leader Kim Jong-un to a naval cemetery for the crew of "submarine chaser No 233". Photographs showed Mr Kim surrounded by more than a dozen gravestones inscribed with the date 13 October. The report said the vessel had been performing combat duties but gave no more information about what happened.

#### India, U.S. launch annual Malabar exercises in Bay of Bengal

NEW DELHI — The Indian and US navies began conducting their annual Malabar joint exercises today in the Bay of Bengal, off the coast of Tamil Nadu, an annual event since 1992. The exercises will run through Nov. 11. The exercises will include gun-firing, fighter combat operations from aircraft carriers, combating terrorism and maritime interdiction operations exercises.

#### Japan putting missiles on Pacific gateway islands

TOKYO: Japan is putting missiles on islands marking the gateway to the Pacific, officials said on Thursday, as part of a huge military drill that has unsettled Beijing. The exercise, aimed at bolstering Japan's defence of remote islands, has already seen a launching system and a loader for Type-88 surface-to-ship missiles installed on Miyako island, complete with two missiles.

ZHOUSHAN, China (AP) - Military flags fluttered in the wind aboard China's navy hospital ship Peace Ark as it began a goodwill mission to the Philippines on Thursday, nearly two weeks after the Southeast Asian country was struck by a devastating typhoon that killed more than 4,000 people. The mission was announced earlier this week following days of critical media reports that compared the international outpouring of aid with tepid early offers of assistance from Beijing, which is embroiled in a conflict with Manila over maritime territory.

#### India trains Vietnamese navy to handle new Russian subs

India's navy is training over 500 Vietnamese submariners as part of the countries' resolution to expand bilateral military ties, the Times of India reported last week. During talks between Indian Prime Minister Manmohan Singh and visiting Communist Party general secretary Nguyen Phu Trong last Wednesday, it was decided that India would issue Vietnam a US\$100 million line of credit for the purposes of enabling the latter to acquire four naval patrol vessels from the former, the report said.

#### World News: Somali pirates shift course

Piracy off the coast of Somalia, one of the world's crucial shipping lanes, has plunged this year because of aggressive military and intelligence steps that have made it too costly for seafaring bandits to operate, regional diplomats and naval officials said. The success, however, has had an unintended consequence: The Somali crime lords behind the pirate networks have shifted to other illicit trade, sometimes in partnership with al Qaeda-linked militant groups like al-Shabaab, aiding terrorism in the Horn of Africa, diplomats and intelligence officials said.

#### Pirates take tanker in Strait of Malacca near Singapore

Pirates hijacked a second tanker in a month off the Malaysian coast near Singapore, Asia's biggest oil-trading hub, according to the International Maritime Bureau. Ten pirates armed with guns and knives boarded a vessel about 7.3 nautical miles (13.5 kilometers) west of Malaysia's Pulau Kukup in the Strait of Malacca, forcing the crew to transfer its gasoil cargo to another ship, the IMB's Piracy Reporting Center said in a Nov. 7 incident report on its website.

#### Japan, Cambodia to boost maritime security

PHNOM PENH - Japan and Cambodia agreed during their summit Saturday that they will seek to enhance maritime security by establishing the principle of the rule of law to settle disputes in the Asia-Pacific region. Japanese Prime Minister Shinzo Abe and his Cambodian counterpart Hun Sen also decided to advance cooperation between their defence authorities and work together to improve health and medical care in Cambodia, according to a joint statement released after their meeting in Phnom Penh.

#### Yolanda death toll nears 4000; damage climbs to P10.4B

Official death toll from Typhoon Yolanda (Haiyan) that ravaged Central Philippines last week jumped to almost 4,000, based on the latest report of the National Disaster Risk Reduction and Management Council (NDRRMC). NDRRMC Executive Director Eduardo del Rosario said that based on the disaster bureau's 6 p.m. update on Monday, the death toll has risen to 3,976. Eastern Visayas reported 3,725 deaths. Around 1,602 are still missing and 18,175 were reported injured. The total cost of damage in Yolanda-hit regions has reached P10,384,690,061 with the agriculture sector suffering the largest lost at P9,089,181,461.00.
